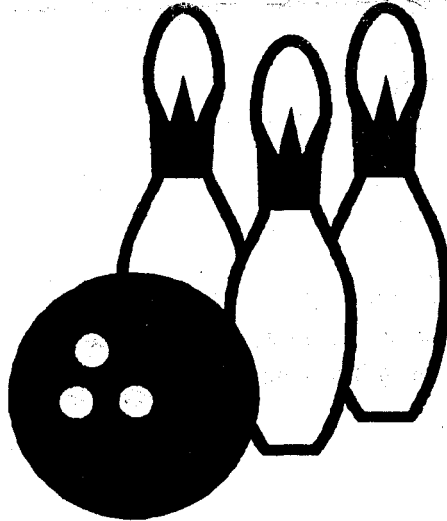

If you attended last year in Kankakee, we hope you had a good time. We would like you to encourage more teams from your area to participate.

Tournament dates are March 31 & April 1, 2012.

There will be dinner served at the Lodge on Saturday night, 31 Mar, with entertainment provided. Also breakfast will be served on Sunday morning at the Lodge. Times, menus, and prices will be available on the bowling alley on Saturday.

Lee's Lanes has a Happy Joe's and a lounge for anyone who wishes to partake in any snacks or cocktails. We ask only that bowlers not drink or eat in the immediate bowling area. This is a NON-SMOKING FACILITY.

Entries are based on the date of the POSTMARKS as to the availability of times, so it is to your advantage to get your registration forms in early if you have a definite preference. We also try to take into consideration traveling distance. We will do our best to accommodate your wish to the best of our ability. Teams will be bowling on Sunday and doubles and singles will be on Saturday.

We do request that these forms be filled out carefully and entirely. This will save a lot of unnecessary telephone calls. Registration forms will advise you when they need to be returned in order to bowl. **PLEASE REMEMBER, NO PERSONAL CHECKS WILL BE ACCEPTED. PAYMENT MUST BE MADE VIA A CHAPTER CHECK, MONEY ORDER OR CASHIER'S CHECK.**

We look forward to seeing many bowlers in Geneseo at the end of March to make this another successful tournament for the WOTM. We are all anxious and excited to welcome you to our City and hope that you will bowl well, eat, drink, and be merry and enjoy your weekend.

RULES

1. Bowlers must be Women of the Moose members in good standing at the time of bowling in Tournament. Chapter certification is necessary.
2. Chapter must be in good standing.
3. Previous tournament winnings do not have to be reported.
4. Any appeal or protest of score must be made in writing within 24 hours after game is rolled.
5. A team, which does not have a full line-up, will not receive any score for an absentee bowler.
6. Any team or individual entered in this tournament failing to appear on the lanes when scheduled to bowl shall forfeit the entry unless the Tournament Chairman finds sufficient reason for granting a postponement.
7. No entry money will be refunded if it is found that some teams or individuals have failed to comply with all rules and regulations governing this tournament.
8. If, in the team, doubles or singles event, a duly scheduled entrant is unable to bowl, the captain shall have the right to substitute a bowler. However, the tournament manager and tournament committee shall have full power as to the acceptance of any substitutes offered for any event. Supported by proper affidavit, each substitute must bowl under her own name and only at the properly scheduled time.
9. All remittances must be made in the form of a Chapter check, Money Order, or Certified Check made payable to the Women of the Moose, earmarked - Illinois State Bowling Tournament. NO PERSONAL CHECKS OR CASH WILL BE ACCEPTED.
10. No entry will be accepted unless paid in full.
11. It shall be a bowler's-responsibility to verify the accuracy of her average, whether originally submitted by the bowler, her team captain or others. Failure to use the proper average or make a correction up to completion of the first game of a series shall disqualify score if submitted average is lower than actual average, or base prize winnings on submitted average if it is higher.
12. Averages that shall be used are:
 - a. Highest average at end of 2010-2011 season, at least 21 games or more. *If no end of season average,*
 - b. Highest average in 2011 summer league, of at least 21 games or more. *If no summer league average,*
 - c. Highest average as of November 15, 2011, of at least 15 games or more. *If no current season average,*
 - d. Highest current league average for 15 games or more as of the date of her participation.
 - e. If none of the above applies, entrant shall use 125 average.
 - f. Ten (10) or more pin increase in average does not apply.
13. Doubles will be bowled first, and then singles. There will be 4 or 6 bowlers to each pair of lanes in the singles and doubles, depending upon the number of entries.
14. To participate in doubles or singles, you must enter both events.
15. A bowler is not eligible to compete more than once in each event of this tournament with the following exceptions: Members of the host city Chapter only will be allowed to bowl more than once for the out-of-town teams to fill vacancies; however, they will qualify for prize money (less entry fee) only, for their first appearance for all events.
16. All prize fees will be returned 100% within each event, on a ratio of at least 1 prize for each 6 entries or major fraction thereof, including team, doubles, singles, and all events.
17. Handicap will be based on 90% of the difference in the average and 200 scratch.
18. All USBC rules will apply.
19. Trophies will be awarded for both scratch and handicap winners with only one trophy for one event awarded anyone co-worker or one team.
20. Check-in time will be a minimum of 30 minutes before scheduled bowling time. If a substitute is used, check-in time is one hour prior to scheduled bowling time.
21. All bowlers must have their Women of the Moose Membership Card.
22. No fees shall be refunded after preparation of schedule.
23. Prize checks will be mailed to the Team Captains.
24. PRIZE CHECKS WILL BE VOID AFTER 90 DAYS.
25. All participants shall be required to sign a liability release form at the time they bowl.
26. In order to be scheduled at the same time, teams doubling together should send entries and fees in the same envelope. Teams that wish to cross lanes together shall submit their entry forms and fees in the same envelope along with their written request to cross lanes.
27. Confirmations will be sent to each Team Captain. It is the Team Captain's responsibility to notify all members of date and time each individual bowls in this tournament.
28. A substitute in All Events must bowl for the same entrant in all 3 events.

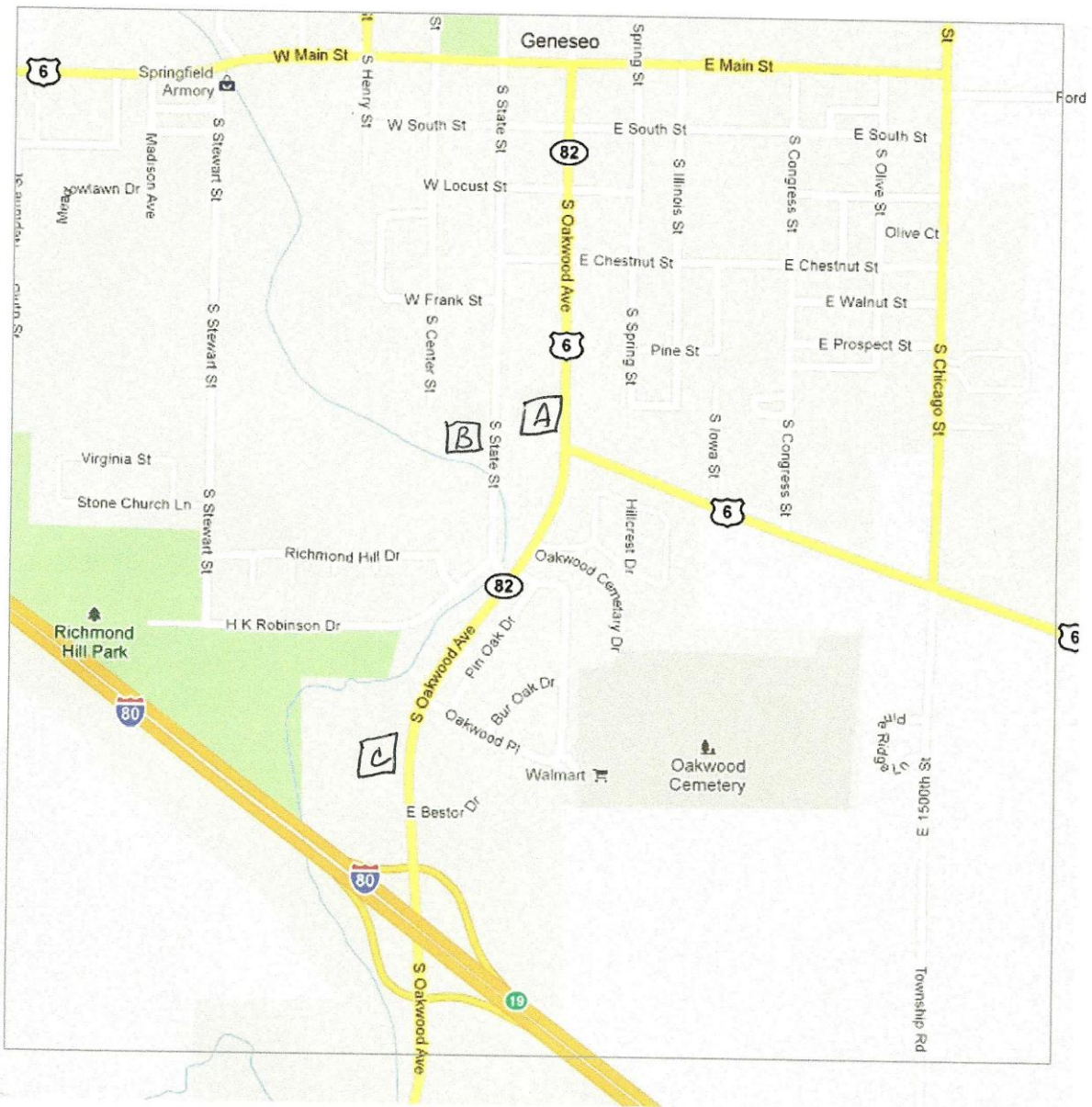
